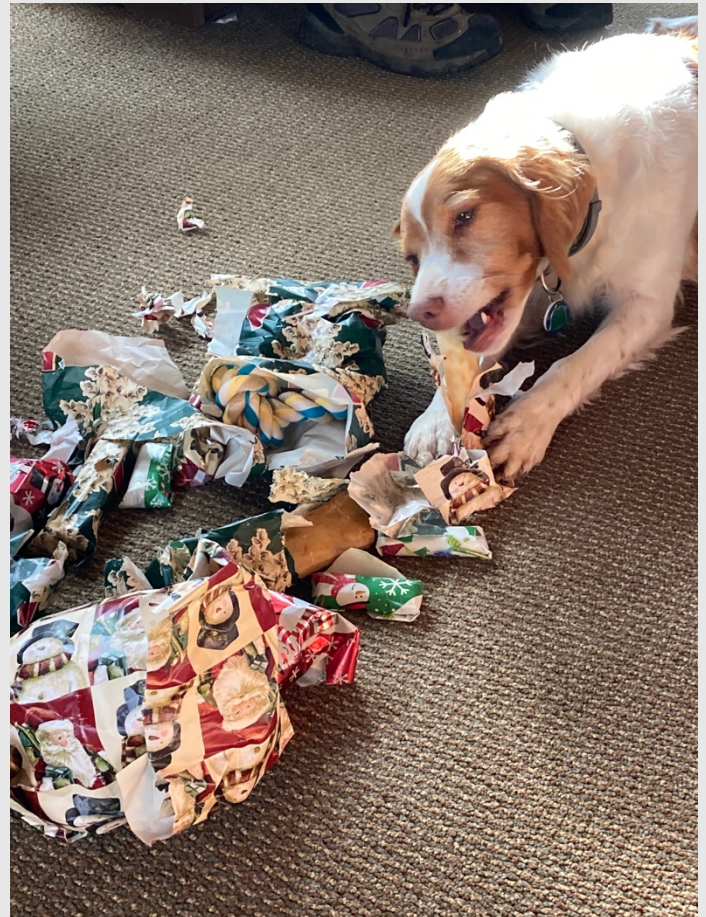

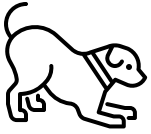

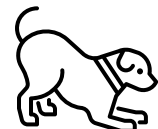

Cindy called for an Alternate Order of Business that the meeting include only action items. Jane made a motion and Carolyn seconded. Motion approved.

Cindy presented a report on the recent Tracking Test which was held on Betsy Keen's property. Four dogs attempted and two passed. Additionally, two dogs attempted their excellent test but neither passed. After fees and the costs for two judges, the test cost the club \$348.34.

Treasurer's August Monthly Report was presented in an email sent from Terry on 9/30/2023. Carolyn made a motion to approve and Lauren seconded. Motion passed.

As of September 27, 2023: Checking Balance: \$ 63,604.93 Savings Balance: \$99,110

In next month's report, you will see I transferred \$5,000.00 to savings. I addressed this last month. I will probably transfer more next month due to several deposits we've made in September. I want to see what our expenses look like to maintain a \$50,000.00+ balance unless the Board decides otherwise.

Recording Secretary – Lori McGill Sarago

E-voting since last meeting: The estimated cost to repair the scrubber is \$600. The value of the scrubber when running is much higher than that. Approval of repairing floor scrubber. With a motion by John and seconded by Lauren, motion passed.

The actual cost to repair the scrubber was \$780 for part. Brian Royer repaired the scrubber and did not charge the club for his labor.

New Business:

ACTION ITEM: Purchase of storage items needed to reorganize south wall of agility equipment (Lauren) -- Lauren, Carolyn, and Su worked together to organize the south wall agility equipment. They would like to purchase shelving for the corner where the poles are stored and new containers with wheels for the poles. The estimated cost is under that which requires a board vote so they will go ahead and purchase the shelving and containers.

Next meeting is November 7 at 6:30 p.m. at DDTC.

Motion to adjourn at 6:41 p.m. by Jane and seconded by Linda. Meeting adjourned.
