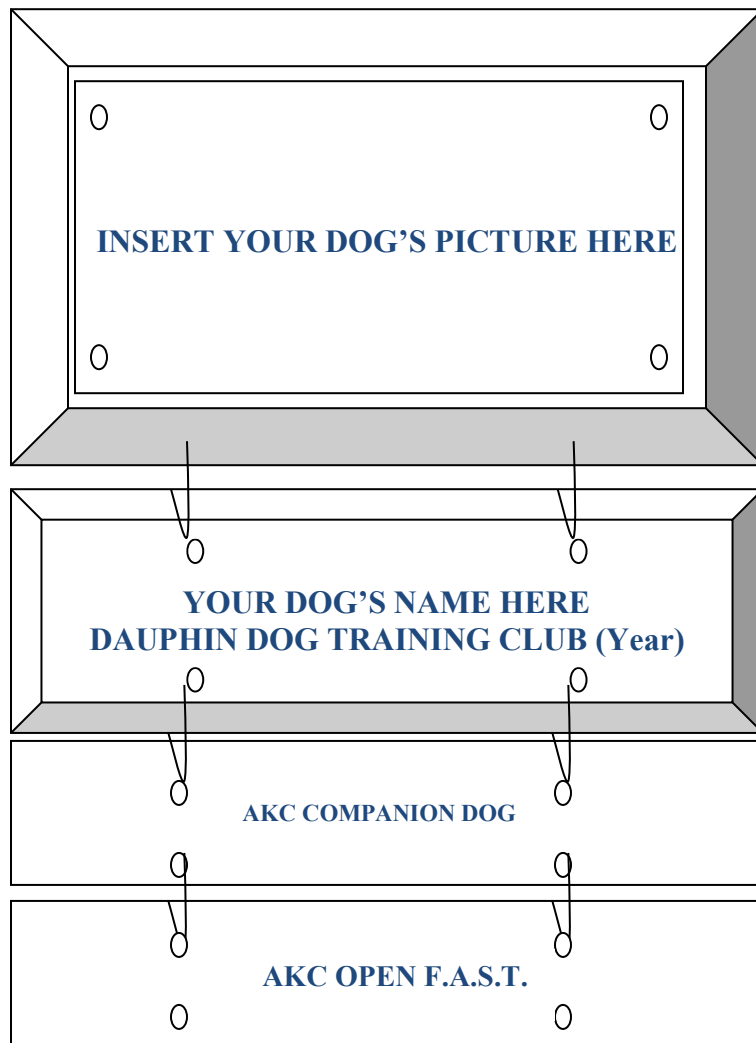

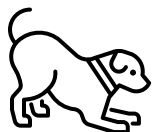

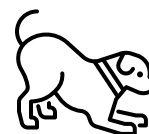

May 6, 2025**

Meeting called to order at 6:30 p.m. at DDTC by President Cindy Miller.

**Excused Absence:** John Delescavage, Karen Frese, Linda Weindel

April Board Meeting Minutes stand approved as published if no objections. There were no objections. Minutes approved.

April Treasurer's Reports stand approved as published if no objections. There were no objections. Reports approved.

An Alternate Order of Business was requested because Lisa had to return to work. Lisa moved and Carolyn seconded that an Alternate Order of Business be approved. Motion carried.

**Reports:**

***President – Cindy Miller***

*Nominating Committee* – Committee is comprised of Carolyn, Jane, Alan Dengler, Amy Ramser and Rosemary Evans. As of now, there will be two vacancies on the Board, the President and the Treasurer. Karen is making a final decision whether or not to rerun and will let Carolyn know by the end of the week. Carolyn will then send an email to the Board to let them know how many positions are open.

*Approval of the Obedience and Agility Registrar Job Descriptions* – The updated Registrar job descriptions were reviewed. Carolyn moved and Terry seconded that the new Registrar job descriptions be approved. Motion carried.

*CPR Classes at East Hanover Township* – Cindy reported that she stopped at the East Hanover Township Building and asked that DDTC be included in their emails regarding when CPR classes will be offered. Each class will be limited to 25 people. Preference is given to township residents; non-residents may fill any remaining open spots.

***First Vice President – Carolyn Dumaresq***

The traction surface on the teeter has become worn through normal wear and tear. We need to have the teeter resurfaced as it is becoming a safety issue. Carolyn's plan would be to have it resurfaced after Agility Camp or possibly after spring classes. She estimates it will cost about \$300 to repair. Vicki moved and Jane seconded that a budget of \$350 for resurfacing be approved. Motion carried.

***Second Vice President – Jane Frantz***

In June, the new displaceable jumps for Obedience will be required. We currently have two jumps; Jane would like to purchase two more that will be used exclusively for shows as well as another jump for regular use. In addition, we would need to purchase 3 bars. Jane and Lauren will research pricing and email their recommendation to the Board; we will then vote electronically.
