#### Dauphin Dog Training Club Board Meeting Minutes March 4, 2025

Meeting called to order at 6:30 p.m. via Skype by President Cindy Miller.

February Board Meeting Minutes stand approved as amended if no objections. There were no objections. Minutes approved.

February Treasurer's Reports stand approved as published if no objections. There were no objections. Reports approved.

#### **Reports:**

#### President - Cindy Miller

- Update on the Insurance Audit completed by Karen, Carolyn and Cindy. It was suggested that
  we create a narrated video of the contents of the two sheds and club building. These videos could
  be invaluable should the club experience significant damage. The videos should be stored off site.
  Cindy requested Su, Lori and Carolyn work together to create the videos. Karen stated if someone
  contacts her, she can pass along suggestions of what should be included in the videos.
- PA Business Report due June 2025 After discussion, the board decided that Cindy will ask Diane Baker whether or not we need to complete this form.
- Review WiFi thermostats The thermostats reset to factory settings again. Should we purchase the WiFi thermostats? Previously, John obtained a quote from HV Mechanical to replace the current thermostats and place sensors around the building. The sensors detect the temperature and direct heat/cooling appropriately around the building. We can program the thermostats AND HV Mechanical can also access the thermostats remotely, possibly saving a service call.

Lori provided quote pricing from notes (\$2,889 for two thermostats and eight sensors). Carolyn moved and Jane seconded to purchase the WiFi thermostats and sensors. Lisa and Karen opposed. All else said aye. Motion carried.

Lisa clarified that she is opposed to having sensors on the walls because she thinks, since they are on the walls, the sensors will always be cold and will keep the heat cycling excessively. Carolyn volunteered to have a discussion with HV Mechanical about whether or not the sensors on the wall will be effective. Will it be worth the money to add the sensors? John will provide the contact information to Carolyn.

Agility will be adding some classes for next semester, due to an influx of new students. There will be two new classes on Wednesdays.

Wendy has updated the website with Jennifer's changes for drop in handling.

#### **Old Business:**

- Flooring Subcommittee (Chair: Terry) Thank you to Su for doing a lot of talking with vendors! The expectation is that we will come out of the next meeting with a presentation to the membership. Terry suspects there will not be one recommendation; rather, they will present the best options for turf and non-turf for comments. Then, it will go to the board for a vote.
- Incident Report Form for People (Su) Jane moved and Carolyn seconded for Su to create an Incident Report Form for people (similar to the dog form). Motion passed.
- DDTC Apparel (Linda) Linda would like some clarification. Lauren left her a catalog from For Imprint and told her that they already have our logo (George). Are we looking for shirts to give to everybody or shirts that when we're at an event, people can identify that we are part of DDTC? Vicki suggests that at least the board should have DDTC shirts.

Linda also contacted Holly's Embroidery that Carolyn had suggested. Linda would prefer to purchase from a local company, rather than a large box company. She's thinking to look at a vest initially.

Update on Google Cloud Storage (Lisa and Su) – Lisa reports they are starting to work on setting
up the file system.

#### **New Business:**

Revisit of Website Password for Members – TABLED

From Sharon: Our Corgi Club (PWCCP) has a member only sign-in/password for member lists, board minutes, job descriptions, etc.

From Heidi: I think it is a good idea to protect information that could be used be scammers and simply to protect members privacy. MNDTC has had a member only access on their website longer than I have been a member.

What to Password Protect: Barker and financial information.

Online Class Registration (Karen) – Karen had provided a document listing several online
registration examples with the associated costs involved. Her question to the board was whether
or not they were open to any or all of the software options, especially relating to cost. If the board
is not open to the potential costs of certain options then she would not spend time researching
them. Several board members began discussing other online registration issues at this point.

Carolyn stated that, as a registrar, she interested in whether or not the system can do things like check if someone has certain skills before registering someone for a certain class. Also, we give preference for board members/instructors. Will the online system make more work or less for things like that?

Su suggested that registrars send list of needs to Karen to keep in mind when reviewing programs. Cindy recommends a subcommittee to consider this question. All registrars should be on the subcommittee. Sally, Jane, Carolyn, Karen and Lisa.

Cindy stated that the club will not be covering the cost of this program. The costs will be passed along in our class fees, FOB prices, etc. The question is whether or not the convenience of registering online is worth the additional money to our members.

Do we need to review the fees for classes, FOB, Open Training? Cindy asks, since we are
reviewing our budget annually, should we be reviewing our fees annually also? General
agreement that it is a good idea. It has been about five years since our last price increase. Karen
suggested that, even if the review is simply to say that our pricing is good as it is, it should be
reviewed annually.

Vicki suggests waiting until we decide what we are doing with online registration before making a decision on price increases.

A subcommittee was formed (Carolyn, Jane, Karen, Terry) to review class fees/FOBs/ membership fees.

• First Aid Kit for Pets – Lauren spoke with Nikki Smith. Either she or her friend will do a presentation at the general meeting on a first aid kit for pets.

Next meeting is April 1 at 6:30 p.m. at the Club. Motion to adjourn at 7:49 p.m. by Carolyn and seconded by Vicki. Meeting adjourned.
