Announcing Online Class Registration Coming for Winter 2026 Session!

Over the last several years, we have heard from our members that having the option to register for classes online would be a great benefit for them. Not only from an efficiency perspective, but more and more, events like FastCat, Agility and Obedience trials, and other performance events have online registration options.

The benefits to members include convenience and flexibility as you can register from anywhere on any internet connected device. Easy access to information as all class schedules, descriptions, and prerequisites are available online, allowing you to browse and select the right classes for your dogs. Automatic processing of registrations and secure payment reduces risk of errors and provides a faster, more efficient experience. These are just a few of the benefits to our members.

So what have we been doing?

This past year, a committee was formed to interview dog training clubs regarding the software they used for online registration and what they liked/disliked about it. Committee members were Carolyn Dumaresq, Jane Frantz, Karen Frese, and Sallie Jordan.

Meanwhile, another committee consisting of Sallie Jordan, Su McKee, and Cindy Miller reviewed and made decisions on topics such as registration open and closing dates, but more importantly, how to pay using vouchers and Dauphin Rewards. We needed to ensure that those payment options would still be viable with any product we choose.

*Given that, the DDTC Board is pleased to announce that for the **Winter 2026 session**, on-line registration will be an option to register for classes.*

At the September Board Meeting, Sallie Jordan was appointed the online class Registrar Manager.

DogBizPro (DBP) was selected as our Online Registration Software

After reviewing the comments, DogBizPro appeared to be the most promising option for DDTC in that it was made for dog-related businesses. Therefore, the club purchased a DBP subscription and has been very busy entering DDTC specific data into the system.

We are currently in the testing phase of this project.

In case you're wondering...

1. Yes. There will be hands-on training sessions at the club. This includes one-on-one help.
2. Yes. Members can still use a paper registration form.
3. Yes. Regular updates will be posted on what is happening and members will receive emails regarding the training sessions.
4. Yes. Tutorials will be posted on our website.
5. Yes. You can pay online with PayPal when you register online for classes.
6. Yes. You can use your vouchers, Instructor Credits, and Dauphin Rewards to pay for your classes.
7. Yes. You will also be able to pay with a check for your classes.
8. Yes. You can hand in your vouchers and Dauphin Rewards at the club during the training sessions. They will be added to your DBP account.

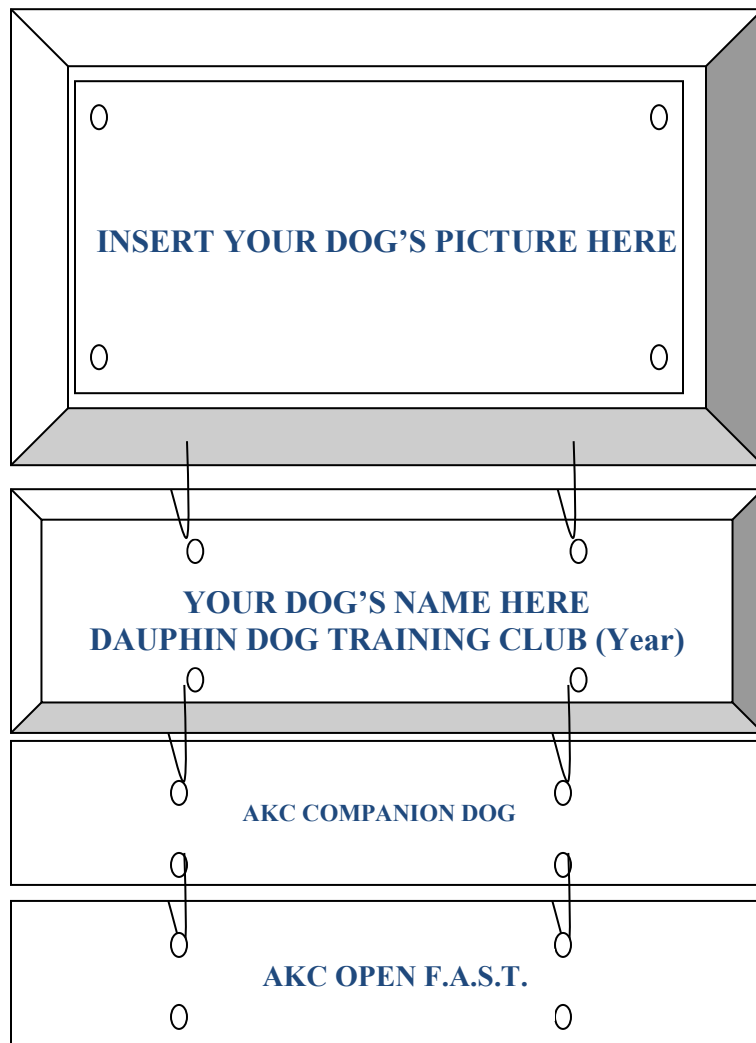

August 5, 2025

Meeting called to order at 6:28 p.m. at DDTC by President Cindy Miller.

July Board Meeting Minutes stand approved as published if no objections. There were no objections. Minutes approved.

June/July Treasurer Monthly Reports:

- June Treasurer's reports stand approved as published if no objections. There were no objections. June reports approved.
- July Treasurer's reports stand approved as published if no objections. There were no objections. July reports approved.

Reports:

President – Cindy Miller

- Per the Bylaws – Approval of Obedience Training Director – New Obedience Director will be Diane Baker. Jane remarked that Diane helps a lot and volunteers at many events. Carolyn moved and Vicki seconded that Diane be approved as the new Obedience Training Director. Motion carried.
- Cindy received an email from Sharon Leh regarding what to do with the required return of Kathy Chervenka's \$20 fob deposit. Sharon proposed using it as a donation to either Heart's Promise Sheltie Rescue or the Humane Society of Harrisburg Area in memory of Kathy. Cindy stated the club does not have a policy regarding memorial donations. John moved and Carolyn seconded that a \$50 donation (including the fob deposit) to both organizations in Kathy's memory be approved. Motion carried.
- Budget versus Actual for the first six months of 2025. It was pointed out that, for the first six months of 2025, our income is \$2,200 over the budgeted amounts and our expenses are \$5,000 under.
- PDFC Banquet – Jen and Don Sudbury are not able to go this year. Cindy and Cheryl will go instead.
- Terry reviewed all instructor contracts. She proposes we make one generic contract with a specific addendum for each sport. Terry clarified that the contract is signed one time but the Training Director is to review the contract with each instructor annually.
- Regarding FastCAT, the premium is now posted and the conflict with the AKC website is resolved. We will have fun runs on Saturday.

First Vice President – Carolyn Dumaresq

- Purchase of agility wicket – The current wicket was broken while stored in the office. Carolyn is asking to purchase a new one for \$397.50. It will be stored in the locked closet, not in the office. John moved and Vicki seconded that the purchase of a new agility wicket be approved. Motion carried.

- Carolyn also asked to purchase a training tool that can be a mini-A-Frame or a mini-teeter. It holds dogs up to 50 pounds and costs \$190. Vicki moved and Jane seconded that the purchase of the new training tool be approved. Motion carried.

Jane reported that the match on Sunday had income of \$890.

His recommendation is to go with Schuler because they have the ability to cut out the section that is chewed up by the garbage trucks and repair it. We are at the "half-life" of our parking lot, so a complete repaving at this point does not make sense. It seems more economical to simply patch, seal and repaint the lines. Schuler is able to do all three at the best price. Terry moved and Carolyn seconded that Schuler's bid be approved. Motion carried.
