

General Membership Meeting called to order at 7 p.m. by Cindy Miller.

- Cindy reminded all attendees to sign the attendance sheet.
- If no corrections, the 2024 General Membership Meeting Minutes are accepted as published in the Barker Annual Issue January 2025 and July 2025. There were no corrections.

General Comments from the President – Cindy Miller

- Mug Award, Award of Appreciation (Certificate of Award), Honorary Member – Nomination forms all due by October 1st. Nomination forms will be in the Barker.
- Annual Awards/Holiday Party is December 6th – Starts at 3 pm.
- All other reports (trials/classes/grounds/treasurer/membership/etc.) will be at the October meeting.

New Business:

- Carolyn explained the process of reviewing the current board and nominating for open positions.
- 2025 Nominating Committee Slate of Officers (Carolyn Dumaresq):
- President: Cheryl Champion, First Vice President: Carolyn Dumaresq, Second Vice President: Jane Frantz, Treasurer: Judi Fell, Corresponding Secretary: Su McKee, Recording Secretary: Amy Ramser, Board of Directors: Terry Barnaby, John Delescavage, Lisa Hetzel, Vicki Long, Linda Weindel, Lauren Zagnit
- Nominations from the Floor – Opened the floor for nominations but no nominations were made. Carolyn submitted the slate as is to Cindy Miller.

Presentation and discussion on proposed Bylaw changes to Article II & new Article XVII (Cindy Miller) – AKC

recently released some sample bylaws. Review of our Bylaws revealed that we needed to update some areas. For example, the single family/senior single membership categories – what was in bylaws and what was on the membership form did not match. Bylaws relating to discipline were reorganized into one section. (Membership section now only deals with types of membership, dues, and termination of membership. Moved the part about discipline to the new Discipline section.)

Presentation and discussion regarding online class registration (Karen) – A committee was formed to look into various online class registration softwares. The committee interviewed other clubs that use online class registration and collected information on what software they use. Dogbizpro looked most promising. Examined a demo to get a better idea of what was offered and how it works. Concurrently, a second committee was formed to discuss topics such as opening/closing dates, how registration would work, etc. The board approved a temporary membership to dogbizpro to test how it works. Information is being entered in the program. There will be plenty of opportunity for learning how to register online. Club members will still have the ability to register using a paper form and check if they are not comfortable using the software.

A question was asked regarding what the fee is for credit card use. Karen explained that the club is absorbing the credit card fee for now. Instructor credits will still be able to be used for class registration. There were a number of questions regarding cost and registration process. Karen asked that many of the questions be held until we have a more formal information session to explain the system.

Presentation and discussion re: class and membership fees. (Karen)

A committee was formed to examine fees due to the fact it's been 5 years since they were revised. After research, the following was included in the decision-making process: operating costs have increased, dues charged by other clubs in the vicinity, recent and anticipated capital expenditures. The following was approved by the board in June:

- FOB Fee – Not changed because availability of club free time is diminished due to all the activities we have.
- Open Training Fee – Changed from \$10 to \$12/hr., effective 1/1/26.

The following changes were recommended for dues and fees:

- Senior Membership Fee – Retain current fee of \$30 per year. New Senior Membership fee will be \$40. This category will be eliminated January 1, 2027. Retain late fee of \$5.
- Senior Family Membership - Retain current fee of \$35 per year. New Senior Family Membership will be \$45. Eliminate this category January 1, 2027.
- Senior Discount for Classes – Current fee is \$55 (7 week class). Increase fee to \$65 (7 week class), effective January 1, 2026. Increase fee to \$75 (7 week class), effective January 1, 2027. Eliminate this category effective January 1, 2027.

General Membership Meeting Minutes Cont. - August 26, 2025

A question was asked as to whether we will retain the "senior" category since we are effectively eliminating the category with the price increases. Cindy suggested we might keep the category for statistical purposes, if nothing else.

Presentation and discussion on flooring options (Terry Barnaby) – The AKC is currently doing a six-month study on flooring/equipment. It would be worthwhile to see what their results are. Committee developed 7 criteria that they used to look at flooring options: cleaning, comfort for dogs and humans, cost, durability, installation, maintenance, and safety of dogs and humans. Terry reviewed each criteria and the specifics of each topic.

When Terry presented the different floorings, she noted that all the comments presented were from the companies, they are not the committee's opinions. She presented each flooring and a brief description of each.

Open Discussion: Ask questions now or email questions to Terry. We do not have estimates yet because we wanted to get your feedback before deciding which products to quote.

Ø What facilities had the turf? Nexxfield – Sports facility near State College. Ecore – ITN is an Ecore product (not the same one).

Ø One member stated that turf does not meet 2010 ADA standards. Terry requested the standards be sent to her.

Ø Both turfs are installed with odor. Su stated it is odorless glue. One of the turfs is available in panels which do not need glue.

Ø A question was posed about instituting a "potty policy" to make people more cognizant of taking their dogs out.

Ø Terry confirmed we already have the cleaning machine recommended by all four companies.

Ø It was asked if there are dog facilities using the other non-turf options. Answer: Yes, there are several we talked to.

Ø What is meant by the term "Athletic factors"? Answer: Things like bending your knees, pumping your arms, etc.

Ø Could we have one ring in rubber; one ring in turf? Answer: No.

Ø Have you gone to a facility where they use turf for obedience, rally, etc.? Answer: Terry has not but others have.

Ø A comment was made that Obedience does a lot outside which has different surfaces. Obedience, AKC invitatorials, and other trials have trials on turf. We all need to be prepared for all types of surfaces.

Ø It was noted that installing new flooring is going to be really expensive! What's wrong with Great Mats since they're the least expensive? (Reiterated to send comments to Cindy.)

Ø All four companies state their product should be "spot cleaned." Can someone determine what the protocol is for spot cleaning for each before the board votes on it? Answer: Terry/committee will look into it.

Ø Ruth Anne stated she just installed Great Mats in her facility which are slightly different than what we have.

Individuals are welcome to come to her facility to see the flooring. Ruth Anne noted that she only cleans with water, not soap, and in her opinion it makes the flooring last longer.

Ø One member commented that she spoke to a judge who stated that turf stinks. Her personal opinion is that turf stinks. A facility member told her they pay \$3,500 each time they need to deep clean the turf. Another question is whether we have to "flush" it? What is the income of agility versus obedience? The current flooring seems to work fine!

Ø Any indication with the floorings that they were only good for one sport? Answer: No. They are for athletics in general.

Ø Since we are multi-sport, is there one flooring that will suit all? Terry stated the committee has tried to find the best flooring options, both turf and non-turf. After feedback from the membership, the board will make the decision.

Ø Concern was expressed that turf is more likely to pick up fleas/parasites if a dog enters carrying them.

Ø A question about the excess hair that is picked up by the turf. How would we clean it? Answer: We vacuum every week which should be sufficient.

Ø What do you need to clean the turf regularly? Answer: Vacuum, just not with metal beater bar.

Ø Does turf need to be cleaned more often than mats? Answer: We are told no.

At the end of the Open Discussion, members were encouraged to send any additional comments and concerns to the President, who will share with the Board for review.

Input/Questions/Concerns from General Membership – No input/questions other than what were made during the meeting.

Motion to adjourn at 8:30 p.m. by Carolyn and seconded by Rosemary. Meeting adjourned.



Annual Meeting Minutes - October 7, 2025

Meeting called to order at 7:00 p.m. at DDTc by President Cindy Miller.

Presentation by Nikki Smith, DVM:

Pet First Aid at Home (including what should be in your First Aid Kit) -

- Cindy will be adding a link to our website that Nikki says is to a great reference booklet on first aid.
- Questions to ask yourself when there's an emergency: How to handle the situation? What to do for my pet? Do they need to go to vet?
- Nikki outlined a number of different scenarios:
 - Anaphylaxis – Can occur after allergic reaction to food, vaccine, bugs. Symptoms can be swollen muzzle, feet, ears. If it progresses to respiratory issues, go to vet.
 - Trauma (hit by car) – Assess dog. Missing hair? Having trouble breathing? Wounds? Flush any wound with clean water but do not put anything on it if going to the vet. Be careful of potential neck/spine injury!
 - Hemorrhage – Spurting blood is arterial. If blood soaks through the bandage quickly, get to the vet!! If comfortable doing so, apply a tourniquet above the wound.
 - Bite wounds – Often a puncture wound. Unless it's quite minor, take dog to the vet. Risk of infection is high.
 - Seizures – Any longer than 5 minutes or multiple seizures in a row, take dog to the vet right away. Shorter seizures don't necessarily have to go to vet right away. Could be seen in a day or two. It's a good idea to video the seizure to show to vet.
 - Eye injury – If cornea is scratched/painful or the eye pops out of socket, take to vet right away.
 - Ingestion of poisons – Chocolate, coffee, grapes, raisins, etc. Call vet right away. Bring the bottle/object along to vet visit. Poison Control number is included in handout. Call for advice if you are unsure if substance is poisonous.
- Tips:
 - When an emergency happens, stay calm! Assess the situation. Check gums. Check hydration.
 - Keep emergency vet clinic numbers and dog vaccine record in kit.
 - Benadryl is also good to have on hand in case of allergies.
 - Tick twisters to remove ticks. Ticklab.org – Can send ticks to be identified and tested for Lyme's Disease.

PA Federation of Dog Clubs Report – The PA Federation of Dog Clubs (PFDC) is a federation of all dog clubs in the state, regardless of affiliation (AKC, etc.). Their purpose is public education and outreach; interaction with legislators; trying to work jointly with NJ Federation of Dog Clubs.

The PFDC annual meeting was held on September 24 and Cindy Miller and Cheryl Champion went in place of our delegates, Jennifer and Don Sudbury, who were attending the Finger Lake Shows.

Topics covered at the dinner included:

- Charlie Hall, who is employed by AKC Government Relations department. He reminded us that the AKC relies on its breeders, owners and competitors to keep them apprised of the local legislation. He shared how breeders in Asbury Park, NJ, lost their breeding rights because the legislation passed before the people caught it.
- Don Beishl, Chief of Staff for the Office of Senator Mastriano. He worked on the bi-partisan Beagle Bill 381, which the State Senate approved and is now awaiting approval from the House. This bill encourages that animals used for research be offered for adoption when they are no longer needed.
- Professor Abby Hodder, Penn State Assistant Clinical Professor of Canine Behavioral Welfare, and Canine Extension Specialist, discussed Humane vs Welfare. Presently, she is working with Amish populations to share best practices.
- Dr. Carmen Battaglia discussed the Working Dog Program located at the University of Pennsylvania Vet School and research on puppies bred for direction. The US does not currently produce enough dogs for the TSA, Police, etc. The AKC has recruited breeders to help with the supply of dogs needed for these jobs.

Jen noted that there has been a change to dog registration in PA. Puppies must now be registered at 8 weeks and are not permitted to be sold until 8 weeks.

 - Online Class Registration will begin with the Winter 2026 Session!

The software we will be using is called DogBizPro and our Online Class Registrar Manager is Sallie Jordan. With the winter session, she will be charge of all class registrations. If you have a question regarding what class you should enter, then contact the Training Directors.
 - We are currently in the testing phase of this project.
 - When the testing phase is completed, there will be tutorials posted on our website and you can begin creating an account for you and your dogs. Yes, we will have help available during the sixth week of Fall classes or you may contact Cindy if you would like one on one help. Yes, you can still use a paper registration form.

Flooring Update

The Flooring Committee thanks you for the many replies (over 25 emails) regarding our presentation at the General Membership meeting. We found them to be informative and are summarizing your concerns. We are committed to responding to each of them over time.

The major concerns raised fall into the following categories:

1. Health and Safety including ADA requirements
2. Cleanliness
3. The needs of all sports
4. Cost

ADA recommendations – We were able to get information from a biochemical engineer with a specialization in rehab/prosthetics who also participates in several dog sports. Wheelchairs are designed for all surfaces and paralympic games are held on turf as well as other rubber and foam. We do have to consider the “transition” from one surface to another.

Best Surface for Safety – Research shows that dog and people are safest on grass and dirt, then turf, rubber and foam. The NFL prefers grass to turf. Different types of turf are made of different material as are many types of flooring – some are easier to clean and will not have the problems found in some facilities. We received a detailed report on the best way to clean and maintain turf through a member. The turf we are looking at does not have the black rubber balls in it.

Next steps:

1. We are planning on site visits with Duratrain and Ecore. We are familiar with Great Mats.
2. Sue McKee is investigating an installer on the East Coast who will come to the club and provide quotes for installing each of the four surfaces.

- Replaced old thermostats with wi-fi thermostats. Did not install sensors for now. We will see how things go through the winter to see if heat is maintained adequately throughout the building without remote sensors.
- Anticipated needs for 2026
 - Looking to replace the DDTC sign in 2026. John is asking for input regarding what type of sign to install.
 - The old fence that runs along the driveway and corner of building needs removed.
 - Well pump and sump transfer pump are both approx. 35 years old and may need repaired/replaced in the near future. Furnaces are 11 years old. HVAC says furnaces are still in decent shape. John asks we treat them with respect!

Annual Meeting Minutes Cont. - October 7, 2025

Events and Trials

Agility/Fast CAT – Carolyn Dumaresq

- ACT 1 and ACT 2 – Since we have a certified judge on staff (i.e., we don't pay any fees), we offer these Agility entry level competitions as part of our Beginner 1 and 2 classes. There is no cost to the club as students who want to log these title
- Agility Trials – We have 6 events totaling 12 days throughout the year. Since the club is not large enough for agility competitions, we must rent other facilities for the trials. We have completed 9 of these days, netting approximately \$14,979. Our final event is on October 17-19 where we anticipate netting \$7,000 based on previous years.
- Fast CAT Trials – We offer two trials a year and are able to offer them on site. Usually they are three days, but we were not able to hold a three day trial in April since the Sunday was on Easter and we were not able to contract for a trial secretary on that day. We netted \$5,743.93. We anticipate making a bit more with our September 19-21 trial since we are back to three days and will have fun runs.
- Summer Camp – A fun activity we can hold at the club! The camp starts on Friday night with puppies and it is followed by two days of Novice-Master level courses. This year we netted \$2,935.
- Seminars – We offer seminars from instructors who compete and often place at the national level. These seminars are favorites of our own instructional staff and they often use their Instructor Credits to pay for these seminars. We accept Instructor Credits from both Agility and Obedience instructors.
 - Judy Kolva offers 7 - one day sessions throughout the year. So far, we have netted \$2,475.
 - Britany Imhoff - This year we scheduled to have 3 - two day seminars. Once we deducted the Instructor Credits, we are showing a small loss of \$658 for two events. We have a final seminar in September. So far, we are booking a profit for the final event. We are also discussing raising the fees for next year. Due to conflicts with our class schedule, we will only contract for two seminars in the 2026 year.
 - Donna Brown offers 2 – two day seminars and, similarly, we are showing a \$425 loss due to high Instructor Credits usage. Again, we are discussing raising the fees for seminars for next year.
- Holiday Party – Coming up the first Saturday in December. If you plan to attend, please let Carolyn know what you will be bringing.

- We served 330 pups in the 2025 class schedule. Before deductions for Instructor Credits and vouchers, we logged in approximately \$19,390.
- We also offered 3 intersessions of three weeks each for Jumpers and Weave Pole skills. \$900 profit.

- A new video display was installed to replace the paper calendar for the club. The same calendar is maintained online to ensure consistency between both formats. The display is also utilized to promote classes and share information with members. Members are encouraged to submit photos of their dogs.
- Wendy has been actively updating the website and Facebook with the latest information.
- Wendy and Su have updated the website for the new online registration program.
- A new desktop computer was purchased for the club's office because the old one could not be upgraded to the latest supported version of Windows.

- Proposed Bylaw changes to Article II Membership and NEW section Article XVII Discipline
- Proposed changes were distributed at the General Membership Meeting and published in the September issue of the Barker.

Vote: One opposed; 37 in favor of bylaw changes. Motion carried.

Increase in Membership fees

- Proposed \$10 increase in Senior Single Membership Dues effective Jan 1, 2027
- Proposed \$10 Increase in Senior Family Membership Dues effective Jan 1, 2027

Motion from Deb Sorosky, second from Vicki.

Proposal to do away with higher new member fees and make them the same as renewals.

Make family memberships \$15 higher than single membership (rather than \$5).

Suggestion from floor that both fee proposals be sent to membership for consideration before voting.

Deb agreed to postpone her proposal to allow all information to be sent to membership. Per Cindy, we will vote on the fee changes in September 2026.

Vote: Unanimous vote to postpone vote on fees until next September.

Increase in Class fees

- Proposed \$10 increase training fee for Senior Members effective Jan 1, 2026 (from \$55 to \$65).

Vote: 9 nays; 29 ayes. Motion carried.

- Proposed additional \$10 increase in training fee for Senior Members effective Jan 1, 2027 -- **DELAYED TO LATER DATE**

During discussion it was found that Agility will allow you to join a class late but Obedience will not. Board will discuss consistency to policy.
