

Sid Burgers was a welcome addition to the family, soon starting his training at classes at DDTC. He was so smart and easy to train, a cookie or two was all you needed to tech him all the signs for Rally. Sid competed at the Australian Shepard National trial in Rally Choice class, like a true pro that he was, he scored 99's in both classes. The judge said to me after the class "You know he worked that hard to please you", at that moment I knew it was time for him to retire.

Instead of trialing, Sid kept Bruce company getting lots of treats while Gertie and Jack carried on as Team Zagnit. As his body started to weaken, one thing never changed, his appetite. Sid would eat anything and everyone learned quickly to keep your hand flat or risk losing a finger!!

We made the hard decision to let him go on November 4, surrounded by those who loved him. It was my privilege to have him as my partner but more importantly to be a truly loved member of our family.







### DDTC General Membership Meeting September 3, 2024 – 7:00 p.m. (General Membership Meeting is for the purpose of nominations)

General Membership Meeting called to order at 7 p.m. by Cindy Miller.

Cindy reminded all attendees to sign the attendance sheet.

The General Membership Meeting Minutes stand approved as published in the Barker Annual Issue January 2024 if no objections. There were no objections.

**Presentation**: What happens to my dog after I am gone? Estate Planning/Wills and Humane Euthanasia – Diane Baker and Nikki Smith

#### **Estate Planning (Diane Baker, attorney)**

- 1. Will The document outlining who gets what and who is in charge when you die.
- 2. *Executor* Someone you appointed to be in charge; or someone your family appointed because you did not select an Executor.
- 3. *Probate Assets* Anything you own individually (including pets); *Non-Probate Assets* anything you own with someone and right of survivorship takes all OR someone for whom you filled out a beneficiary form.
- 4. Power of Attorney Designates who can sign for you if you are not able to handle signing by yourself. This document is effective immediately. If you do not have one, your children or dependents have to go through the process of being appointed Guardian.
- 5. Living Will or Medical Power of Attorney (POA) Appoints someone to be involved in your medical care or end of life decisions. (A way to get around HIPAA concerns.)

Wills in terms of pets: After you set up an Executor, fill out the form to report to AKC that there is an Executor. Be sure you have your AKC certificates in a safe place. Otherwise, if AKC certificates are not found, you should file that they are lost and get new ones. If a pet is co-owned, the co-owner has right of survivorship. If you know your end of life is approaching, consider transferring your dogs' papers ASAP. If you are appointed POA for someone, it is best to transfer dogs prior to death of owner. It becomes more complicated to transfer ownership after the owner's death.

In a temporary situation, a POA allows a person to take care of someone's dogs and pay their bills while they are also taking care of the person's bills.

Regarding trusts, yes, you can fund a trust to take care of your animals. However, trusts only really work if the trust is for a significant amount of money. To create a trust you must create an entity – the trust has to have a number, an accountant, a manager, etc. Also, it must be specific to the animal so you will need to set up a new trust for each new animal.

It is recommended that you have a person who agrees to take your animals AND have a back up plan. One option to fund your plan is by leaving that person money in your will. Discuss with your friend that the money is for care for the pet. Keep in mind, if you have no pets at the time you pass, the money still goes to that person who can use it or donate it.

Do not mention your pets by name in your will by name. Have a separate letter entitled "Special Things to Special People" that you include with your will. Create a list of items you want given to specific people; i.e., my dogs go to this person. Do not make it conditional! This is a letter from you so it does not need to be witnessed and does not need to be drawn up by an attorney. Just be sure to sign and date it.

Lastly, Diane pointed out a planner that was included in the handout that will help a person organize their paperwork and finances to assist their executor/family after they pass. She recommended that your pet instructions be included in this planner, too.

#### **Humane Euthanasia (Nikki Smith, veterinarian)**

Nikki spoke on the topic of euthanizing pets when the owner dies. She recommends having this conversation with your vet prior to death, if possible. Ask your vet, "If I die, will you euthanize my animals?" Times when this option might be appropriate is if you are elderly and have an elderly pet. Or if you have a pet that is not well socialized or not easily placed. It may be more ethical to have the pet put to sleep if you are entering care/hospice than to try to rehome your pet.

If your animals are young/well-socialized, it is usually better to rehome them than to euthanize. Remember that sometimes breeders will take pets back and find a new home. Also, keep in mind that veterinary records will not be released without a POA. Another option is to have someone's name added to the veterinary records indicating that you will be transferring the pet to that person. The ability to transfer veterinary records is most important for dogs of high value or dogs that have an ongoing medical issue so that the new owner may need the dog's medical history.

Nikki also provided a list of resources regarding grieving the loss of pets. Many of us love our pets like children so we may need assistance with how to deal with their loss.

#### **General Comments from the President – Cindy Miller**

If anyone has topics for next September's meeting, let Cindy know. Some suggestions from the floor were: puppy contracts; pet insurance.

#### Flooring Status (Terry Barnaby) Two handouts

We have been talking about new flooring for a while and have formed a committee to look into the topic. What is the appropriate surface for our club? First thing was, what are the decision-making criteria (general guidelines provided)? What are the current products that are available? Second handout is the process we are following (in general).

Will be having a meeting this month to look at the process (plan). What floorings to consider? Look into cost, installation, what needs done with subflooring, etc.

Romaine Halupa made a recommendation to look at the Ralston Purina Farms facility because they have many different types of shows there and it is a beautiful facility.

Jennifer and Don are our new representatives to the Federation. They are going to the annual dinner and will have a report in October.

There is now a monitor on the wall to display our calendar, instead of the paper version. This will also allow the calendar in the club and the online calendar to be synced! Lisa is working on it to make it so that we can update the calendar from home.

October 2023 Annual Meeting Minutes -- If no corrections, the 2023 Annual Membership Meeting Minutes stand approved as published in the Barker Annual Issue January 2024. There were no corrections. Minutes approved.

#### Presentation by Jennifer and Don Sudbury:

PA Federation of Dog Clubs – The PA Federation of Dog Clubs (PFDC) is a federation of all dog clubs in the state, regardless of affiliation (AKC, etc.). Their purpose is public education and outreach; interaction with legislators; trying to work jointly with NJ Federation of Dog Clubs.

PFDC deals not only with legal questions but can reach out in other ways. For instance, they interact with the legislature regarding upcoming laws/bills. They also discuss agriculture laws which include all animals, not just dogs.

Jen encourages the membership to not use the phrase "puppy mills." There are probably 50 different definitions of what a puppy mill is or isn't. It's a trigger term which arouses emotions. We want to be careful of assigning numbers to the definition. If you have two intact females and one has a litter which includes 3 females, do you now have 5 breeding females?? Also, remember that ALL animals are included in these definitions, not just dogs.

Jen suggests helping seniors to take care of their dogs so it doesn't rise to the level of abuse. Many times, the elderly cannot brush their dogs out properly so the coat gets matted or nails curl. We need to help each other!

We have faith in our dog wardens to keep breeders up to standard. If you think a breeder is substandard, ask to see their facility. If they will not allow you to see their facility, there may be a problem.

Keep in mind that, often, the legislature is only contacted by a couple of groups regarding their specific agenda. If we are not alerted to the meetings, we cannot be present to rebut the point of the special interest groups. Jen and Don are going to talk with PFDC about making sure we are notified of these meetings.

A suggestion was offered by Jen Hudson that we reach out to local 4-H clubs that offer dog handling programs.

#### Treasurer – Karen Frese

- Year-to-Date Summary Review of cost to run the club: monthly subscriptions, utilities, trash/sewer, internet/printing, insurance. Total is over \$45,000/year. Karen also offered a brief overview of the stormwater tax for those not familiar with what it is.
- Variances Cindy explained our application to change our use from Kennel to Dog Training Facility. We also applied to be allowed to have a food truck on the property.

#### Building & Grounds – John Delescavage

Summary of updates and improvements done in 2023/2024

- A/C is in good condition
- We redecorated inside somewhat. Regrouped pictures and had vinyls hung to label each grouping.
- Installed new monitor for an electronic calendar.

#### 3 current issues

- Septic system We are installing ADA power flush toilets and may need to change the baffle on the septic system.
- Fred Way is removing brush/shrubs from the front of building. He will put down weed barrier and river stone when he is finished.
- Water run off John is obtaining bids from two excavators to put in a ditch along the south side of the driveway and remove part of the bank in front of the storm drain. This work should divert all water run off to the storm drain so the driveway does not ice up during winter.

Question about flooring: Cindy reported that Terry is heading up a committee to research flooring. They are sending a questionnaire to several clubs whose flooring we like to find out more information about it. Cindy has asked Terry to get back to the board by summer with a recommendation so that it can be presented to the membership next year.

#### **Events and Trials**

#### Agility/Fast Cat – Carolyn Dumaresq

- We have re-done the agility curriculum so there are specific entrance and exit requirements. These skills will be used to place handlers/dogs in the correct class.
- Act 1 & 2 are titles that can be used as a way to get used to showing how to fill out forms and how to handle the dog. DDTC is offering both jumpers and standard titles.

- A lot of our one ring agility trials are held at Bella Vista; our 2 ring trials are at In the Net.
- Reviewed the new Agility League Each league consists of 6 weeks of courses; handlers/dogs earn points and are ranked on a national scale.
- Fast Cat Usually make about \$6,000 per trial.
- Seminars We often don't make as much profit on seminars as we could because instructors attend and use Instructor Credits for continuing education.
- Agility Camp Held annually in August at the club.
- Holiday Party Coming up the first Saturday in December. If you plan to attend, please let Carolyn know what you will be bringing.

#### Obedience/Scent Work/Rally - Jane Frantz

- Class statistics We held seven more classes this year than last year, including our first Fetch match and trial ever! We will be holding another Fetch match and trial in November.
- Our Tracking trial will be held in October.
- We will be offering our first ever Ask the Judge seminar for Obedience and Rally. Tina offered to
  participate for Conformation but we will need to wait until next time to take advantage of her offer.
- Dates for 2025 Matches/Trials were available in a hand out.
- Jane presented a page reporting on Obedience/Rally trials and classes cost and profit for 2024.
- July scentwork trial had a profit of \$2,951.09.

Jane met with Tina Leininger and discussed holding a health clinic next year. Tina has experience running health clinics and will be the person engaging clinicians. She recommends scheduling about a year in advance as most professionals are scheduled a year out. In her experience, these clinics are good money makers for the club.

#### IT/Website – Lisa Hetzel

- Lisa did not receive a report from Wendy on the website.
- This year, Lisa added a UPS system (uninterrupted power supply) which keeps the computer running and, therefore, maintains the doors during a power outage.
- Discussion of updating website A small panel was created for feedback and to explore what
  features we'd like to see on the website. This panel was tabled after we were able to update the
  current website with the information we wanted to add.
- Addressed online payments Lisa reminded the members that data security is a real concern. She does not feel comfortable having to protect everyone's payment data with our system.
- Intro to Electronic Calendar Testing a couple of different systems to see which is the best
  solution for the club to show the calendar on the new monitor. Lisa recognizes that some people
  would like to see 3 months at a time, which is not feasible right now. She is looking for other
  options as well as trying to arrange it so that the calendar at the club and the online calendar are
  synced.

#### Barker Information & Communications – Heidi Miller
